

Terms and Conditions for the Invitation Process for VCC Targa Time Trial

Application to enter the 2020 VCC Targa Time Trial is a two stage process. Time Trial entrants follow the same route as the competition vehicles and the number of entries accepted is limited to a maximum of 50.

The Organisers reserve the right to decline any application without disclosing the reason.

1: Application Form:

Once you have completed the online Application to Compete & paid the non-refundable deposit of \$600 please send a photo of your car. If your application is unsuccessful, you may be asked to submit another vehicle for consideration. Vehicle details and modifications must be filled out. If details are found to differ from that given, your invitation may be rescinded and fees forfeited or excluded from all results.

2: Acceptance:

Once your application is received and accepted by the Vehicle Selection Committee, the successful applicant will be advised via email with an Acceptance of Entry Certificate and an invoice for payment.

An entrant wishing to change the vehicle originally nominated must notify the organisers who reserve the right to withdraw the original invitation and consider the proposed replacement vehicle as a new application. Additional crew members may be nominated as replacements.

3. Entry Fees: All entry fees must be paid in full by the date on the invoice. The entry fee includes Lunches for two per day, two Prize-giving tickets, VCC Targa Time Trial livery and a set of Route books. Two Legends Dinner tickets are included for VCC Targa Time Trial entries.

Not included in any entry fees are: Accommodation, Insurance, additional Functions and Fuel, however accommodation and function packages are available on request.

4. Payment: A non-refundable deposit of \$600 must accompany the completed online "Application to Compete" before your application will be considered. Entry fee must be paid in full by the due date on the invoice. If entering all events. Entry fees may be paid by instalments, either by bank automatic payment or credit card (credit card fees apply). 5. Refunds: All withdrawals must be in writing. The following is the criteria for refunds:

(a) If an application has not been accepted the deposit will be refunded.

(b) An applicant who has been accepted and withdraws their application before being notified will forfeit their deposit.

(c) An applicant who has been accepted to compete and who withdraws from the competition prior to three months before that event start date will forfeit the deposit.

(d) Any applicant withdrawing from the VCC Targa Time Trial within three months of the start date of that event will forfeit the deposit and an additional amount of \$1200.

(e) Any applicant who wishes to withdraw and transfer their entry may do so at the discretion of the organisers. Up to 75% of all payments made may be transferred to another Club Targa organised event within the next 12 month period, providing payment terms are up to date and the vehicle nominated is acceptable to the Vehicle Selection Committee.

6. VCC Targa Time Trial Licences, Car Eligibility & Insurance: All crew members (driver and co-driver/s) must have a full civil driver's licence. Proof of a minimum of third party insurance for the vehicle entered must be supplied at Documentation.

All entrants in the VCC Targa Time Trial must be current financial members of the Vintage Car Club NZ and enter a VCC eligible car (30+ years old) with a current VCC Vehicle Identity Card (VIC). Current financial VCC members with a road legal car not eligible for a VCC VIC may only enter at the discretion of the organisers.

7. Safety Equipment: All vehicles must be road legal with current registration & WOF, carry a first aid kit, reflective safety warning triangle, tow rope/strop, 1kg fire extinguisher, and have the car battery securely mounted with "live" terminal covered.

Each vehicle must also have a RallySafe GPS unit active at all times during the event. An overview of the RallySafe system (which also provides significant safety benefits), can be found on www.rallysafe.com.au RallySafe NZ will hire to Time Trial entrants and install in their car, all necessary fittings including the display unit, suction cup, connector and 3 in 1 antenna (which sits on top of the unit), for NZ\$50 per car.

In addition, a power cable costing \$32 for a 3 mtr lead or \$40 for a 5 mtr lead must be purchased and fitted to all vehicles prior to the event.

Total fittings hire & power cable fee (including GST), is either NZ\$82 for fittings hire + 3 mtr power cable or NZ\$90 for fittings hire + 5 mtr power cable.

Those entrants from 2018 or 2019 who already have a power cable fitted to their car need only pay the NZ\$50 hire fee.

(Please note that the above costs are in addition to RallySafe access fee of \$300+GST paid with entry fee).

8. Supplementary Regulations: Can be viewed on the Targa website www.targa.co.nz Supplementary Regulations specific to the event you have entered will be posted on the website approximately 6 weeks prior to the event.

9. Tyres: There is no restriction on the number and make of tyre you can use.

10. Service Crew: are not required.

11. VCC Targa Time Trial Categories:

One category is proposed for 2020 (as for the 2019 event) with average speeds varying according to stage conditions, rather than fixed for all stages. For example, there will be a slower average speed set for tight stages, and a higher average speed set for open, flowing stages.

12. What is the Format?

- Targa NZ 2020: 14th October- 18th October 2020 - 5 day Event
Documentation: 13th October 2020
